

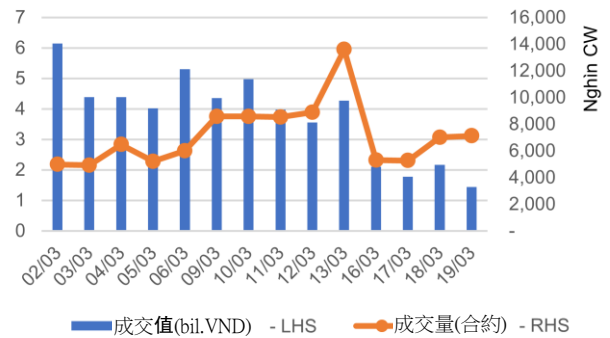

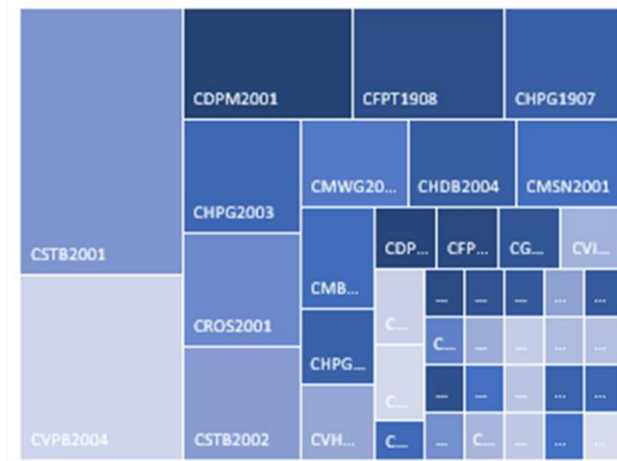
### 流動性耗盡

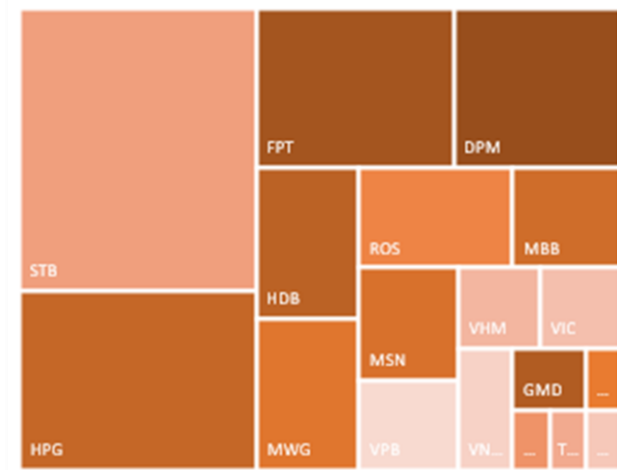
成交值和成交量

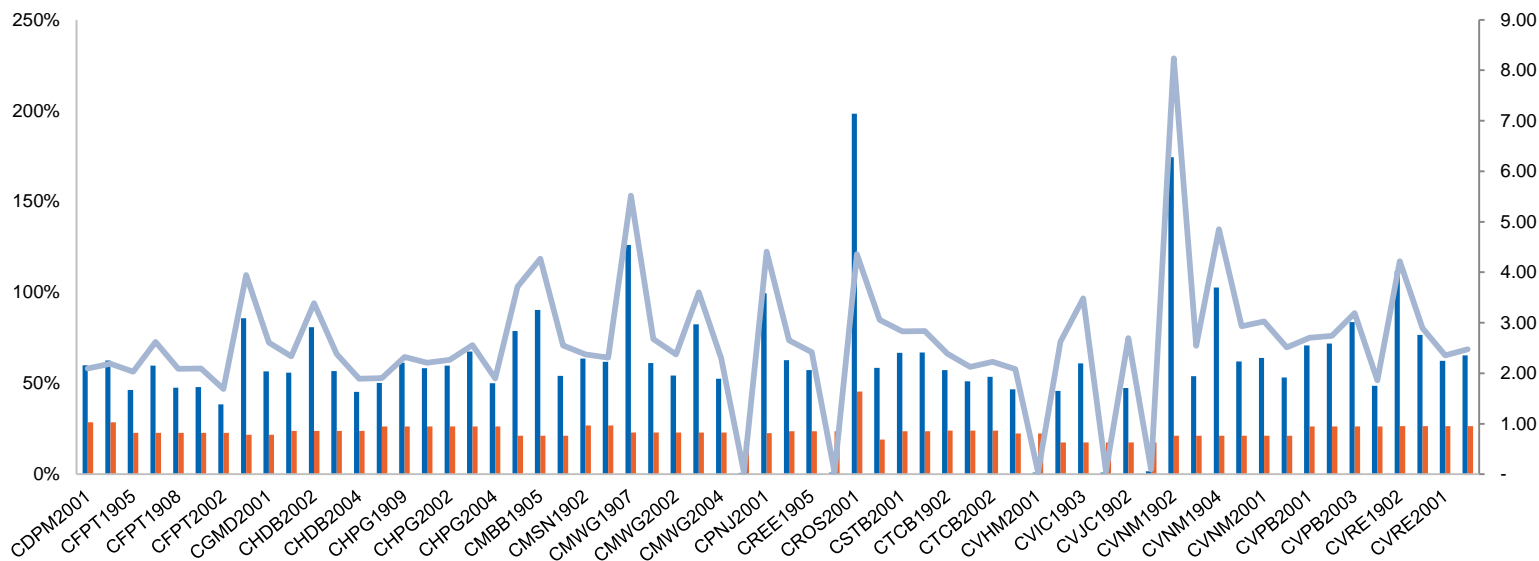
