



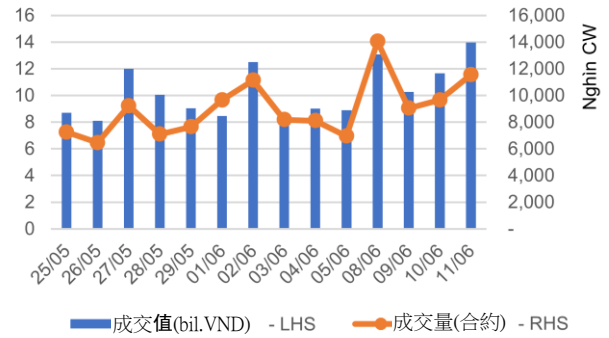

權證同時下跌

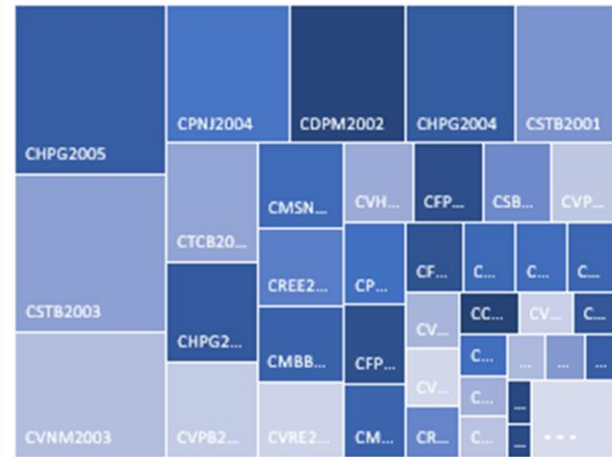

成交值和成交量

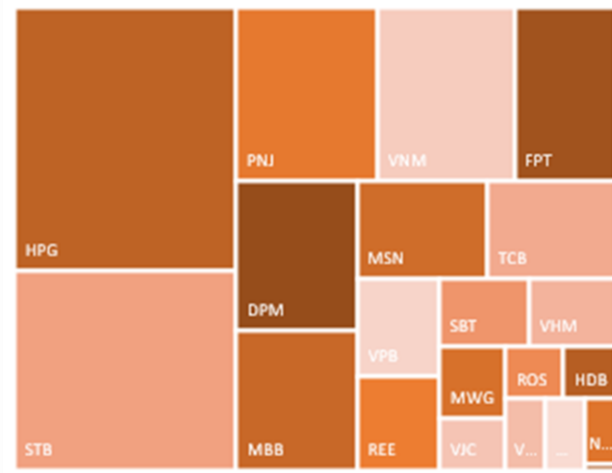


根據認股權證代碼分配成交值

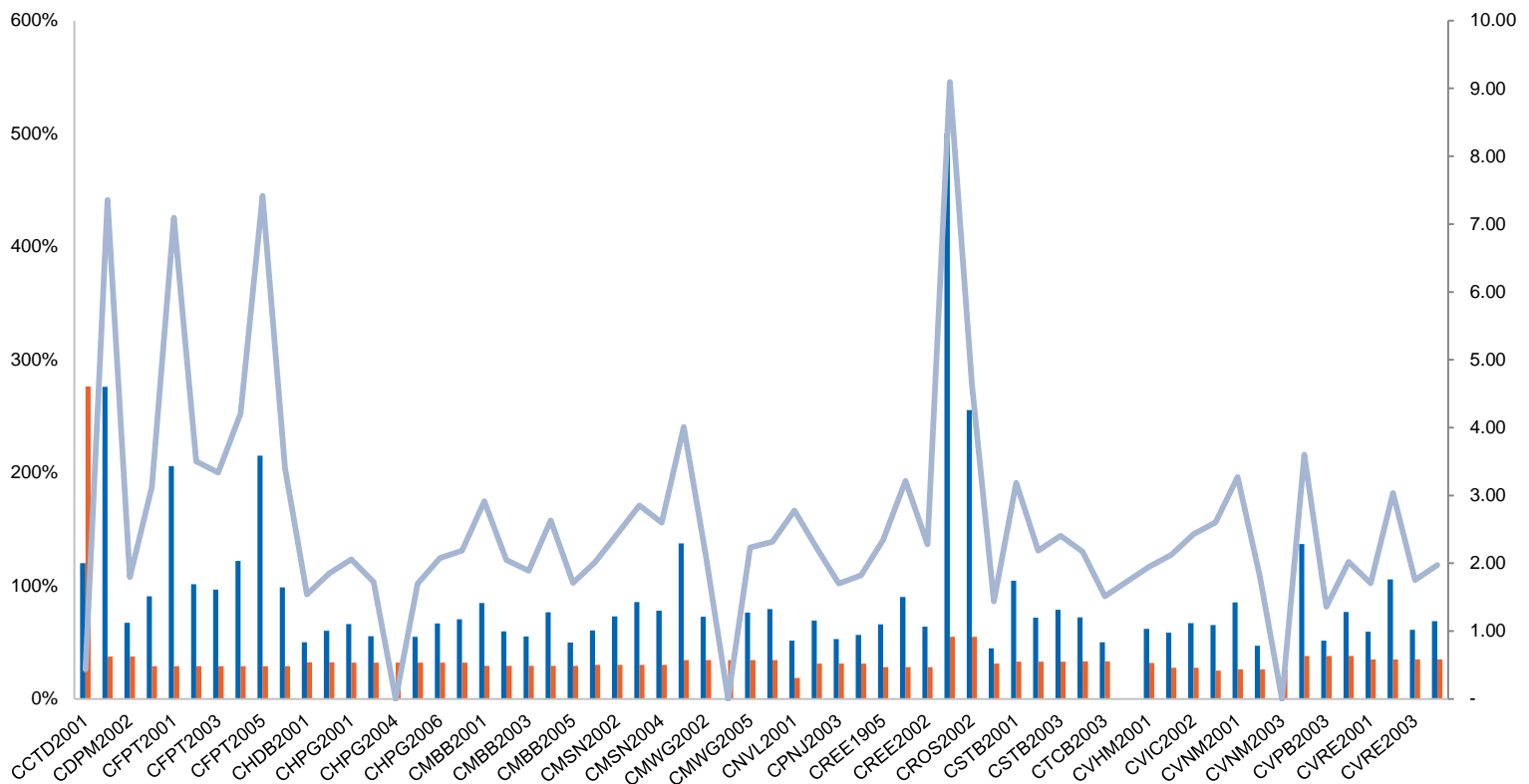
